


Background


Initially many of us thought that COVID-19 is just a usual type of virus that will come and go. But this expectation has proved totally wrong. The virus has become the largest blow to the human society after WWII. While health is the first domain affected by the Pandemic, economic and social impacts are going to be even more devastating. Recovery to the Pandemic is not about going back to the old situation but to a new normal which we still don't know.



How the developing and emerging economies in Asia build back their economies determines the security, peace, and prosperity in the region and globally. Rebuilding after the Pandemic must also consider climate change — we cannot tackle multi-hazard crisis by acting in silos. As a small contribution towards strengthening recovery, IFSD has launched Community of Practice Initiatives (CPI) to targeting young, emerging and early career professionals. The four streams of CPI include: Health security, food security, water security, and climate security.

Themes and scope of learning and engagement

Resonating with the expertise and work coverage of IFSD, the CPI themes cover the areas of water security, good security and climate change. We have added health security as an additional but critically important thematic area for this Initiative.



Under each of these initiatives, we will aim to achieve the following learning and engagement outcomes for the interns as well as the larger community of practice participants:

Learning objectives

Learning and engagement strategies

You will be working directly under an expert mentor and the management team of IFSD.

Time frame

These three month-long internships (October -December 2020). You will need to participate in fortnightly online activity for sharing the updates with mentors, peers, or stakeholders.
